

# RAP BACK RENT ASSISTANCE DOCUMENTATION LIST

The below documents are needed to determine your eligibility and affordability for the Rental Assistance Program. Please bring all documentation to your appointment.

1. Court Ordered Hearing Notice, Landlord Tenant Complaint or Recovery of Real Property Notice.
2. 30 to 90 days proof of gross income for each household member.
3. Picture ID and Social Security Cards for all Adult household members. Birth Certificates and Social Security Cards for all children in the household.
4. Current rent ledger from landlord indicating back rent owed
5. Verifiable documentation from a third-party (received from someone other than yourself) which shows the financial reason for unpaid rent. Examples: Receipts from unexpected or emergency expenses paid out, proof of income loss or reduction, employer statement of leave without pay.
6. Current Lease
7. Current Bank Statement - Including Chime, Cashapp, etc.
8. Proof of County Assistance Benefits - ex. Compass Report
9. All monthly household expenses, such as: Utility Bills, Car payments, Insurance bills, Cell phone bills, Court Fees, Child Care Expenses, Child Support Order.
10. Proof of any family, friends' financial assistance (as applicable)

**Please arrive at least 10-15 minutes BEFORE your appointment time to complete your Rental Assistance Information Packet. Anyone arriving 15 minutes late for their scheduled appointment will have to reschedule.**

# RAP MOVE-IN ASSISTANCE DOCUMENTATION LIST

The below documents are needed to determine your eligibility and affordability for the Rental Assistance Program. Please bring all documentation to your appointment.

1. Verifiable documentation from a third-party (written by someone other than yourself) of your current living situation and why you must move. Examples: verification that you are not legally permitted to stay where you are currently living, verification of property being sold, condemned or lease not being renewed (must not be deemed an undesirable tenant), exit date from shelter, institution or program.
2. 30-90 days proof of gross income for each household member.
3. Picture ID and Social Security Cards for all Adult household members. Birth Certificates and Social Security Cards for all children in the household.
4. Approval letter for new residence.
5. Current Bank Statement - including Chime, Cashapp, etc.
6. Proof of County Assistance Benefits - ex. Compass Report
7. All monthly household expenses, such as: Utility Bills (for electric bill contact PPL for an estimated bill for your new residence) **for all other utility bills request information from landlord**, Car payments, Insurance bills, Cell phone bills, Court Fees, Child Care Expenses, Child Support Order.
8. Proof of any family, friends' financial assistance (as applicable)
9. A signed lease will be required before final approval/exit appointment.

**Please arrive at least 10-15 minutes BEFORE your appointment time to complete your Rental Assistance Information Packet. Anyone arriving 15 minutes late for their scheduled appointment will have to reschedule.**
